2. Applicable mail types: Airmail items (including letter-post items, ePackets, parcels and EMS) and S.A.L. parcels (Canada and USA).
3. Rate calculation: "Weight per item" multiplied by "Rate per kilogram", rounded to the nearest whole number.
4. Discounts are not applicable to Emergency Situation Surcharge.
